Recipe

Berry Poke Cake

- 1 Box Betty Crocker white cake mix
- 1 pkg. (4 oz. size) strawberry or raspberry Jello
- 1 Cup boiling water
- 1 1/2 Cup cold water
- 1 (8 oz.) container Cool Whip
- Fresh fruit if desired

Heat oven to 350 degrees. Make cake as directed on box. Cool completely. Poke cake all over with fork. In small bowl, stir gelatin and boiling water until dissolved, stir in cold water. Pour over cake. Run knife around sides of pan to loosen cake. Refrigerate for 2 hours. Spread Cool Whip over top of cake. Garnish with berries. Store covered in refrigerator.

Note—Lime Jello makes a delicious cake, as well. Great dessert for warm weather.
