GROUNDS COMMITTEE

It's that time of year once again where all members are required to clean their lots, campers, RVs and all outbuildings. A ride around will be done on May 15th and letters will be sent out to those in violation of this covenant rule. I have included the covenant below for those in question of this requirement.

Article IV Association Powers and Responsibilities

B. Maintenance Section 1. Association Responsibility. The Association shall maintain and keep in good repair the Common Area, such maintenance to be funded as hereinafter provided. This maintenance shall include, but not be limited to, maintenance, repair, and replacement, subject to any insurance then in effect, of all landscaping and other flora, structures, and improvements situated upon the Common Area. **Section 2. Owner's Responsibility.** Subject to Article X hereof, the maintenance responsibility of an Owner shall be as follows: (a) All maintenance of Lots, unless specifically identified hereunder or in a Supplemental Declaration or other applicable Declaration of Covenants as being the responsibility of the Association or another party or entity, shall be the responsibility of the Owner of such Lot. (b) In the event the Board of Directors of the Association determines that (i) any Owner has failed or refuses to discharge properly his or her obligations with regard to the maintenance, repair, or replacement of items for which he or she is responsible hereunder; or (ii) that the need for maintenance, repair, or replacement which is the responsibility of the Association hereunder is caused through the willful or negligent act of an Owner, his or her family guests, lessees, or invitees, the Association, except in the event of an emergency situation, shall give the Owner written notice of the Association's intent to provide such necessary maintenance, repair, or replacement, at their sole cost and expense; the notice shall set forth with reasonable particularity the maintenance, repair, or replacement deemed necessary and the cost thereof. The noticed party shall have thirty (30) days within which to pay such amount claimed; or, in the event such maintenance or repair is to the owner's Lot complete said

maintenance repair, or replacement; or, in the event that such maintenance, repair, or replacement is not capable of completion within said thirty (30) day period, to commence such work which shall be completed within reasonable time. If any Owner does not comply with the provisions hereof, the Association may provide any such maintenance, repair, or replacement at such person's sole cost and expense, and the cost shall be added to and become a part of the assessment to which such party is subject and shall become a lien against the Lot of such party.

Work is being done on the pool in the attempt to have it opened by Memorial Day. Rewiring and new signs required by the county and state are just a few of the things needed to have it ready for your enjoyment. Bridge work needs to be done which will require delays for motor vehicles. Maintenance will begin the first week in May in the mornings. So expect delays and please be patient while we make the necessary repairs.

The washing machine and folding chairs are on order and are expected in soon.

A big THANK YOU goes out to Shirley Williams, Barbara Camp and Kathe Hyman for cleaning up the common areas and to Roger for maintaining the blueberry bushes and the Memorial Garden. Great job y'all!!

RECIPE OF THE MONTH:



**Slow-Cooker Cranberry-
 Orange Pork Roast**

Prep Time: 15 min.
 Total Time: 4 hr. 25min.
 Servings: 16 servings

Ingredients:

- 2 Tbsp. oil
- 1 flat boneless pork loin roast (4 lb.)
- 1 can (14 oz.) whole berry cranberry sauce
- 1/2 cup KRAFT Classic CATALINA Dressing
- 1 Tbsp. lite soy sauce
- 1 Tbsp. cornstarch
- 1 tsp. zest and 1/4 cup juice from 1 orange

Directions:

Heat oil in large skillet on medium-high heat.
 Add meat; cook 4 to 5 min. on each side or until evenly browned on both sides. Transfer meat to slow

cooker sprayed with cooking spray.

Mix cranberry sauce, dressing and soy sauce until blended; pour over meat. Cover with lid.

Cook on LOW 4 to 5 hours. Remove meat from slow cooker, reserving liquid in slow cooker. Cover meat to keep warm. Whisk remaining ingredients in small bowl until blended; stir into liquid in slow cooker. Cook, covered, on HIGH 10 min. or until thickened.

Slice meat; place on platter. Drizzle lightly with sauce. Serve with remaining sauce.

**Mastro's Signature Warm
 Butter Cake**

Cake Batter

- 2 cups (4 sticks) unsalted butter, room temperature
- 4 ounces cream cheese, room temperature
- 2 1/4 cups granulated sugar
- 2 large eggs, room temperature
- 1/2 teaspoon fine sea salt
- 1 1/2 cups all-purpose flour
- 1 1/2 teaspoons vanilla extract

Cream Cheese Layer

- 4 ounces cream cheese, room temperature
- 1 egg, room temperature
- 1/3 cup granulated sugar
- 1/2 teaspoon vanilla extract

Preheat oven to 325.

Spray 4 mini springform pans with baking spray. You can also use oversized Ramekins or a mini soufflé pan.



WARM BUTTER CAKE continued

Prepare the cake batter :

In a stand mixer cream butter, cream cheese, and sugar for 1-2 minutes. Add eggs one at a time and beat on low for 20 seconds after each addition. Whisk flour and salt, then add to creamed mixture. Beat on low until just incorporated, making sure not to over beat.

Prepare the cream cheese layer:

In a small bowl whip together cream cheese and granulated sugar until creamed, add egg and vanilla extract. Pour cake batter into prepared springform pans then top with a layer of the cream cheese mixture. Bake for 60 – 75 minutes, or until tops are golden brown and a toothpick comes out clean when inserted into the center of the cakes.

Cake can be made a day ahead. When ready to serve microwave until hot approx 1 minute on 80% power then with a kitchen blow torch brûlée the top and sides of the cake to caramelize the sugar crystals.

To serve this cake *a la "Mastro's"*, top with a generous scoop of vanilla ice cream, top with strawberries and top with a sprig of fresh mint.

On the following pages are the monthly reminders, park information and Dos & Don'ts. Print them out to look back on and to keep for handy reference.

DO'S & DON'TS

COMMON SENSE CONSIDERATIONS & PARK INFORMATION:

RIGHT-OF-WAY: Motor vehicles and RVs have the RIGHT-OF-WAY over golf carts. It's much easier for a golf cart to move off the narrow roads than a larger vehicle!



GARBAGE: The **Dumpsters** (by the mailboxes) are for Household Waste Only. Break down all boxes flat that are to be placed in the dumpsters. Items other than household waste; chairs, tables, small appliances, flower pots, etc. need to be taken to the **Roll Off** dumpster located down by the trailer storage area. These items are not to be placed in or around the garbage dumpsters.



Be aware of where you put your garbage bags! People have put them on top of their cars and driven away and forgotten them, only to have them fall off over the park roads or on Paradise Valley Road.

Items have been found in the roll off that are in perfect condition. The Community Thrift Store is located on 1160 E Kytle St (Rte. 115) in Cleveland and they accept most things in good condition to which they donate some of the profits to local charities. Give them a call if you have any questions tel:706-865-0574. And PLEASE... do not leave items outside the roll-off. Can't get your item into the roll-off? Ask for help!!



WATER CODES: Have you noticed the numbers and letters on the gate and have no idea what these mean? Paradise has a code system in the park for water and sewer issues. The explanation to this is: the number "1" represents side one in the park. This encompasses lots 1 thru 194, which are all on the entrance side of the park. The number "2" represents side two of the park.

Which encompasses lots 195 thru 290, which are all the lots over the bridge. The letter "B" represents a Boil Notice is in effect. This means, if posted on the gate, that all lots affected by a water problem must boil their water prior to use. Notices are posted by the mailboxes, on the bridge board and at the laundry room. Also, an e-Blast with this information is sent out to all residents who are registered on the PVCOA.com website. If you have not registered on the website, you will NOT receive this information via your email.

CONSERVING THE PARKS EXPENSES: Please remember to turn off the lights in the pavilion, rest rooms, laundry and to close down the umbrellas at the pool and put them in the ladies' and men's room. This will extend their life for future years. Straighten chairs in the pavilion, breezeway, pool...in other words treat the park like you would your own home, because it is! Remember the expenses incurred to repair, replace or fix these issues come from your pocket!


GEORGIA DNR (Department of Natural Resources) prohibits any and all changes made to the creeks and streams. Trees or vegetation cannot be removed from the side of the creek. Clearing can only be done up to the top of the bank. This means that moving rocks or natural vegetation and dumping debris of any kind into the waterways are illegal. Please be aware the county has in the past issued fines for these violations.



POOL: The outdoor shower at the pool is to be used for washing off suntan lotion and perspiration prior to entering the pool. NOT to cleanse your body....that should be done at your cabin/RV! The safety rope across the pool is a Georgia State regulation and is NOT to be played on or removed.



COMMON SENSE continued



BOOK & MOVIE DONATIONS:

Anyone who has been to the laundry has seen the numerous books, games and tapes/CD's that surround the walls. All these items have been generously donated by members of PVC. They are there to borrow and return afterwards for others to appreciate. Please feel free to donate the above items for others to continue to enjoy throughout the years!

WATER SHUT OFF: When leaving the Campground for more than 48 hours, it is imperative to shut your water off at the main valve in order to prevent damage to your property and to protect the overall water system in the campground.

SEPTIC: Please be very mindful of what you put into the septic system. It is important that you remember not to pour grease down your drains. Feminine products, wipes, non-biodegradable waste should not be flushed down the toilets. This has caused MAJOR problems in the past that resulted in expensive repairs.

Roger is not the campground manager, he is our work camper. His responsibilities come from a member of the board, NOT an individual owner in the park! If you have an issue or suggestion that needs attention, please contact a board member and they will handle the issue.



PETS: Those of us who have them know only too well how special they are to us. But not everyone feels the same way, so PLEASE be considerate to all! No pets are allowed in the pool area or the pavilion. Be sure to carry plastic bags when walking your dog to clean up after them. No dog enclosures, whether

temporary or permanent, are allowed to be put up in the park.

MOTORCYCLES: Are not permitted to ride around the park like a golf cart. They are only allowed egress and ingress only. Please comply with this rule.



911 EMERGENCY CALLS: When calling 911 from a cell phone, you must specify **White County!** If you don't, you could lose much-needed minutes as your call will go to Lumpkin or Habersham County, and they transfer your information to White County. Be safe and remember, White County! When at the pool or pavilion, please note there is a phone outside the laundry room door for emergency use.



WI FI SERVICE: For those of you who do not have Internet access available at your cabin or trailer, it is available to you. Come, relax and get your emails at the Pavilion. Sign into free Internet service. The code and password are as follows:

QUIET TIME: Quiet time is 11 p.m. to 8 a.m. Using motorized equipment or any loud noises is prohibited between these hours.



POST OFFICE: If you do not have a mailbox, your mail cannot be left at the PVC mailbox area.

Arrangements must be made with the Cleveland post office to manage the handling of your mail.



DO NOT Let anyone through the gate that you don't know!! It's for everyone's safety!!





Board Members

The board members are volunteers who devote their time and effort to keeping PVC what it is... "the best RV park in Cleveland." Please be mindful of this when you get upset that something is not being taken care of, i.e. American flags being put in the dumpster, the blueberry bushes and common grounds not being maintained, dog droppings not being picked up. VOLUNTEERS NEEDED!

We are ALWAYS looking for volunteers as there are ALWAYS things to do around and for the park. If you wish to help and be an active part of your community, please see a board member with your contact information. Pulling out your tools and lending a helping hand with cleaning up the common grounds is one way to get these areas looking good early in the season!!



DELIVERIES: Waiting for a package to arrive and have no idea where it will be

delivered? Check the sales office (the building on the right side at the entrance with the mailbox in front) it was formally the real-estate sales office. It is now where packages are delivered from UPS and FedEx. So, stop in periodically to see if your package arrived safely.
