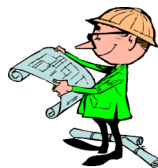
There will be events held in our campground throughout the season and these events will be advertised in the Pipeline (or Bulletin), on the message boards located

ARCHITECTURAL SITE AND IMPROVEMENTS COMMITTEE

Prior to beginning any construction or major improvements to your property, contact must be made with the Architectural Committee. If you are in doubt as to whether a permit is required, please contact a member of the Architectural Committee.

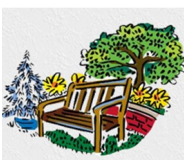
There is no requirement for a PVC permit for general maintenance (i.e. painting the same color, minor deck or cabin repair. If you plan on changing colors, a park permit will be required and some projects may require a White County Building permit as well. Please make sure that you pick up and post (in plain sight) the Park's Architectural Permit BEFORE work begins.

The purpose of this committee is to help property owners who are planning new construction or repairs and to ensure compliance with our covenants and building standards. To make the process easier, the application forms for a (PVC) permit are available on the Paradise Valley website at pvcoa.com. All park permits have an expiration date, which is noted on the permit. If your permit expires before the work is started or completed you must apply for a current permit.

Please remember it is important to check with the county before applying for a park building permit. **All** new construction must have a park permit and possibly a county permit as well. For more details please see Article 10, Section 24 of the PVC Covenants. Permits must be returned to the architectural committee after construction is completed.

The season begins in April and at that time new permits will gladly be issued. Please be reminded that no building of decks, outbuildings (sheds, etc.) or any new construction, painting of outbuilding, cabins, (if the color is being changed) are permitted after October 31st. Therefore, no permits will be issued after October 1st, to April 1st.

Every lot should have (at the very least) signage showing their 911 address (in case of a medical emergency). This is allowed under "Article X" Section 5. "Sign and Billboards", in the PVC covenants. Please be advised that in case of a Fire or Health Emergency, the fire department must be able to locate your property.



GROUNDS COMMITTEE

Welcome back to Paradise!

To all residents, old and new, I have just a few things to run by you.

When bagging leaves, do not include any trash or dog

waste. The bags are to be placed at the roadside for weekly pickup. No leaves are to be blown into the ditches, creek or green space. We ask all members to help keep the ditches in and around your property clean of debris. This will help maintain all the drainage ditches from overflowing during heavy rainfalls.

The dumpsters are only for household waste, garbage and/or trash. Any large items such as small furniture, small appliances, chairs, tables, flower pots, etc. are to be taken to the **Roll Off** dumpster located down by the trailer storage area. These items are not to be placed in or around the garbage dumpsters, but placed inside the dumpsters. Need help? Please contact a board member, friend or neighbor for advice or assistance.

Limbs that have been falling or cut from bushes or trees must be cut into 4 ft. lengths bundled, tied and placed at the edge of your property, (road side, clear for vehicles to pass) for pick up by Perry, our common ground landscaper.

Billy Camp and I have cut fire wood over the winter. It is stacked by the tractor shed on Hidden Valley Road. Please take only what you need for your fire, so everyone can equally share and enjoy.

The Grounds Committee would like to remind you that this is the time of year to begin clean up of your property. The Board will begin checking for lot violations regarding clean up on May 15th. Please make arrangements to have your property cleaned and your RV or Park Model washed as soon as possible if you are not here in the park.

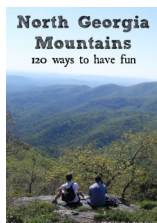

RECIPE OF THE MONTH:

Quick Chicken Minestrone and French Bread with Cauliflower Cheese Sauce

Brightly colored vegetables add some welcome vibrancy to this easy soup that's just comforting enough for cooler nights and fresh enough for any time. Have fun with the noodle shape, or use any small pasta you have on hand. If you'd like, sprinkle each serving with freshly ground black pepper for a finishing touch. Serve with ooey-goopy [French Bread with Cauliflower Cheese Sauce](#) that has a secret extra dose of vegetables (and more creaminess) from steamed cauliflower.

Yield Serves 4 (serving size: about 1 3/4 cups)

Ingredients

- 1 tablespoon olive oil
- 1 cup diced yellow onion
- 1 cup diagonally sliced carrot
- 1 tablespoon minced garlic
- 2 teaspoons unsalted tomato paste
- 4 cups unsalted chicken stock (such as Swanson)
- 1 cup water
- 5/8 teaspoon kosher salt
- 5 ounces uncooked alphabet or ditalini pasta (about 1 cup)
- 1 cup diagonally sliced sugar snap peas

Calories 297, Fat 5.5g, Satfat 1g, Monofat 3.1g, Polyfat 0.6g, Protein 24g, Carbohydrate 38g, Fiber 4g, Cholesterol 38mg, Iron 3mg, Sodium 610mg

Instructions: Heat a large Dutch oven over medium-high. Add oil to pan; swirl to coat. Add onion and carrot; sauté 4 minutes. Add garlic and tomato paste; cook 2 minutes, stirring occasionally. Add stock, 1 cup water, and salt; bring to a boil. Add pasta to pan; cook 5 minutes. Add snap peas, tomato, and chicken to pan; cook 3 minutes or until pasta is done.

French Bread with Cauliflower Cheese Sauce

Ooey-goopy cheesy bread gets an extra dose of vegetables (and more creaminess) from steamed cauliflower. Use this mixture for your next grilled cheese sandwich and pair alongside fresh tomato soup for a family-friendly dinner. We recommend spreading this on crusty French bread to soak up our Quick Chicken Minestrone soup but you can use any bread you prefer. The cheesy-veggie sauce is a great way to sneak in vegetables, so try tossing it with fresh pasta for a healthier mac and cheese that doesn't skimp on the creamy texture and cheesy flavor. If you love to dip garlic bread into broth-based soups or hearty stews, try adding finely minced garlic to the food processor to add an extra kick before spreading the sauce on the bread.



RECIPE OF THE MONTH *continued...*



Ingredients:

- 5 ounces whole-grain French bread, halved lengthwise
- 1 cup fresh cauliflower florets
- 1/3 cup unsalted chicken stock (such as Swanson)
- 1 1/2 ounces reduced-fat cheddar cheese, shredded
- 1/8 teaspoon freshly ground black pepper

Step 1- Preheat broiler to high.

Step 2 - Place bread, cut side up, on a baking sheet. Broil 1 1/2 minutes or until bread is lightly toasted.

Step 3 - Place cauliflower in a steamer basket over simmering water; cover and steam 8 minutes or until very tender. Place stock in a small microwave-safe bowl; microwave at HIGH 30 seconds or until warm. Place cauliflower and stock in a food processor; process until smooth. Add cheese; process until combined.

Step 4 - Spread cauliflower mixture over bread halves; broil 4 minutes or until lightly browned. Cut into 4 pieces; sprinkle with pepper.

DO'S & DON'TS

COMMON SENSE CONSIDERATIONS & REMINDERS:

RIGHT-OF-WAY: Motor vehicles and RVs have the RIGHT-OF-WAY over golf carts. It's much easier for a golf cart to move off the narrow roads than a larger vehicle!



PETS: Those of us who have them know only too well how special they are to us. But not everyone feels the same way, so PLEASE be considerate to all!

No pets are allowed in the pool area or the pavilion. Be sure to carry plastic bags when walking your dog to clean up after them. No dog enclosures, whether temporary or permanent, are allowed to be put up in the park.

MOTORCYCLES: Are not allowed to ride around the park like a golf cart. They are only allowed egress and ingress only. Please comply with this rule.



911 EMERGENCY CALLS: When calling 911 from a cell phone, you must specify White County! If you don't, you could lose much-needed minutes as your call will go to Lumpkin or Habersham County, and they transfer your information to White County. Be safe and remember, White County! When at the pool or pavilion, please note there is a phone outside the laundry room door for emergency use.

WI FI SERVICE: For those of you who do not have Internet access available at your cabin or trailer, it is available to you. Come, relax and get your emails at the Pavilion. Sign into free Internet service. The code and password are as follows: **WI FI Network Code: Win_5d, WI FI Password: z9huuksg**

QUIET TIME: Quiet time is 11 p.m. to 8 a.m. Using motorized equipment or any loud noises is prohibited between these hours.



POST OFFICE: If you do not have a mailbox, your mail cannot be left at the PVC mailbox area. Arrangements must be made with the Cleveland post office to manage the handling of your mail.



COMMON SENSE *continued...*

GARBAGE: The **Dumpsters** (by the mailboxes) are for Household Waste Only. Break down all boxes flat that are to be placed in the dumpsters. Items other than household waste; chairs, tables, small appliances, flower pots, etc. need to be taken to the **Roll Off** dumpster located down by the trailer storage area. These items are not to be placed in or around the garbage dumpsters.

Be aware of where you put your garbage bags! People have put them on top of their cars and driven away and forgotten them, only to have them fall off over the park roads or on Paradise Valley Road.

Items have been found in the roll off that are in perfect condition. The Community Thrift Store is located on 1160 E Kytle St (Rte. 115) in Cleveland and they accept most things in good condition to which they donate some of the profits to local charities. Give them a call if you have any questions tel:706-865-0574. And PLEASE... do not leave items outside the roll-off. Can't get your item into the roll-off? Ask for help!!

WATER CODES: Have you noticed the numbers and letters on the gate and have no idea what these mean? We have a code system in the park for water and sewer issues. The explanation to this is: the number "1" represents side one in the park. This encompasses lots 1 thru 194, which are all on the entrance side of the park. The number "2" represents side two of the park. Which encompasses lots 195 thru 290, which are all the lots over the bridge. The letter "B" represents a Boil Notice is in effect. This means, if posted on the gate, that all lots affected by a water problem must boil their water prior to use. Notices are posted by the mailboxes, on the bridge board and at the laundry room. Also, an e-Blast with this information is sent out to all residents who are registered on the PVCOA.com website. If you have not registered on the website, you will NOT receive this information via your email.

CONSERVING THE PARKS EXPENSES: Please remember to turn off the lights in the pavilion, rest rooms, laundry and to close down the umbrellas at the pool and put them in the ladies' and men's room. This will extend their life for future years. Straighten chairs in the pavilion, breezeway, pool...in other words treat

the park like you would your own home, because it is! Remember the expenses incurred to repair, replace or fix these issues come from your pocket!

GEORGIA DNR (Department of Natural Resources) prohibits any and all changes made to the creeks and streams. Trees or vegetation cannot be removed from the side of the creek. Clearing can only be done up to the top of the bank. This means that moving rocks or natural vegetation and dumping debris of any kind into the waterways are illegal. Please be aware the county has in the past issued fines for these violations.

POOL: The outdoor shower at the pool is to be used for washing off suntan lotion and perspiration prior to entering the pool. NOT to cleanse your body....that should be done at your cabin/RV!

The safety rope across the pool is a Georgia State regulation and is NOT to be played on or removed.

DONATIONS: Anyone who has been to the laundry has seen the numerous books, games and tapes that surround the walls. All these items have been generously donated by you, the members of PVC. They are there to borrow and return (in good condition, of course) afterwards for others to appreciate. Please feel free to donate the above items (providing there are in excellent condition) for others to continue to enjoy throughout the years!

WATER SHUT OFF: When leaving the Campground for more than 48 hours, it is imperative to shut your water off at the main valve in order to prevent damage to your property and to protect the overall water system in the campground.

SEPTIC: Please be very mindful of what you put into the septic system. It is important that you remember not to pour grease down your drains. Feminine products, wipes, non-biodegradable waste should not be flushed down the toilets. This has caused MAJOR problems in the past that resulted in expensive repairs.

Roger is not the campground manager, he is our work camper. His responsibilities come from a member of the board, NOT an individual owner in the park! If you have an issue or suggestion that needs attention, please contact a board member and they will handle the issue.

DO NOT Let anyone through the gate that you don't know!! It's for everyone's safety!!

The board members are volunteers who devote their time and effort to keeping PVC what it is..."the best RV park in Cleveland." Please be mindful of this when you get upset that something is not being taken care of, i.e. American flags being put in the dumpster, the blueberry bushes and common grounds not being maintained, dog droppings not being picked up. **REMEMBER...**this is **YOUR** park, too. It's up to **ALL** owners to do their part to keep this park maintained. So **PLEASE**, if you see something happening that isn't right, say something, in a nice way. Some people may not realize or know the rules. Take part and act, not complain. BOD hours are 8 a.m. to 4 p.m. Monday - Friday. Be considerate call before going to their lot! They're here to enjoy Paradise also!



American flags are to be burned in ceremony! Don't know how? Hang on to them, ask a board member what procedure to follow. Perhaps they can be collected and burned in ceremony at one time!

FedEx building on the right side at the entrance with the mailbox in front) it was formally the real-estate sales office. It is now where packages are delivered from UPS and FedEx. So, stop in periodically to see if your package arrived safely.
