


<u> President – Jim Zilaro</u>

12/31/2020 Approved Covenant Changes

<u>1). Article X, Section 5 – Signs and Billboards: Second</u> sentence.

New sentence to read: Notwithstanding said prohibition, lot owners shall have one sign per lot, not to exceed 5 square feet in size, giving the name of the lot owner, the number of the lot and the "911 address," <u>and must be clearly visible from the street</u>.

2). Article X, Section 18 – First sentence. New sentence section (a) to read: (a) No burning of leaves, trash, garbage, or other refuse shall be permitted.

<u>3). Article X, Section 25 – Storage Buildings;</u> Make Section 25 into 2 parts (a) & (b). **No change of wording occurs.** Part (a) remains as is currently stated in original Section 25 and <u>Part</u> (b) merges Article X, Section 40 and becomes Part (b). <u>Proposed Change - New Paragraph Section 25 (a)</u>

BREAKFAST IDEA...



Chorizo and Sweet Potato Hash

Sweet potato breakfast hash with crumbled chorizo sausage and diced scallions. This super satisfying one skillet breakfast is a perfect way to greet a crisp spring morning! This sweet potato breakfast hash features cubed sweet potatoes, crumbled chorizo sausage, pan-fried eggs, and diced scallions. You can either steer the flavor palette towards the savory side by adding dried thyme or oregano. Or try something a little different and take it towards the sweet side by adding a touch of maple syrup and some warming cinnamon. It is a matter of personal preference and there is no right answer, so you do whatever you think you will enjoy best.

Tips & Tricks

Ingredients

- 1 medium-size sweet potato, peeled if desired
- 2 green onions
- 1 tablespoon oil
- 2 oz crumbly chorizo, or Soyrizo
- 1 teaspoon maple syrup
- ¹/₈ teaspoon cinnamon
- 2 eggs
- Salt to taste

Instructions

- Cut the sweet potato into ¼-½ inch dice and finely chop the green onions (green + light green parts).
- Heat the oil in a skillet over medium-high heat. Once the oil is shimmering, add the sweet potato. Toss to coat, then cook for 5 minutes, stirring occasionally, until just beginning to soften.
- Add the green onions and cook for an additional 5 minutes.
- Once the potatoes are tender, add the chorizo. Cook for 2 minutes or until cooked through. Add the maple syrup and cinnamon, and season with salt as needed. Stir to combine.
- Make two wells in the hash and crack an egg into each. Cook the eggs to your liking

 we cover our skillet with a lid for about 2 minutes to make sunny side up eggs.
- Serve & enjoy!

Did you know?

The first Plat (lot map) for Paradise

Valley Campground II was recorded in 1993; III in 1994. Remarkably PVC reached nine phases: probably a record for an RV Park. Phase IX was recorded in 2001. Developer lots were sold until mid-2006. An "anti-new RV park", White County RV Park Code was adopted in 2005. It placed certain restrictions on lot improvements in existing parks. County Permits / Inspections in the nineties were at best, minimal. Current Permits, Inspections and Planning review, tends to mirror most urban areas, although the County is mostly rural. White County regulations are constantly changing so verify carefully and do not assume you may do what was done in the past or that today's rules (practices) will be good tomorrow. Construction permits for new cabins are now often processed through a County, make work, "Variance" procedure, which has largely had outcomes favorable to owners, although of course at extra cost in White County fees. USE: Since 2015, we have received endless questions about general Lot use, renting here and living here, too. John Coons has written the below to provide answers, a basic understanding of the current situation, and a brief description of what has transpired.

RENTING: The Paradise Valley Board in the Spring of 2015, following a "winter of difficulties", (2014/2015) authored and issued a "rental protocol" which directs, "no rental of lots from November through March". In 2016 a Board sponsored By-Law change was voted and approved by the general ownership to establish the Annual Season as April 1 to October 31. This action strengthened rental period limitations by relating to "seasonal" language found in both White County and Paradise documents. There is currently NO Lot renting November through March. **OWNING:** Paradise and White County documents specify "recreational use" for Paradise Valley Campground. However, about 35 Lots are occupied by owners all year; they reside here. There is no prohibition against staying on your "owned" lot at any particular time of year. In 2015 the Board initiated a program to "identify and enroll" those

residing in Paradise, as "Caretakers" and assigned each one off-season duties.

1) You are welcome to purchase and use a lot for your RV home base if you actually travel some with the RV, or simply use your lot seasonally or intermittently. Similarly, if your lot has a "parked" RV, or park model, or any form of RV other than a "moving RV", seasonal, intermittent use or use with extended absence, is welcome. A separate (location elsewhere), maintained legal residence (address, driver's license, insurance, tax filing) is significant in establishing and/or verifying these criteria under questionable circumstances.

2) You are not to simply occupy a lot, with any type of RV unit, and just be present there continuously, annually, as if your lot /RV were a single-family home; thereby establishing residence. Exceptions to this condition, are those owners given "Caretaker" status by the Paradise Board of Directors and those grand-fathered.
